#### Ask an Advocate

What is an order of protection and an injunction against harassment?

An order of protection (OOP) is a court order prohibiting a specific person (defendant) from having contact with the plaintiff, this includes in person contact, on the phone, text message and on social media. The order also protects the plaintiff's home, workplace, school, or other locations.

An injunction against harassment is a court order prohibiting one person from harassing another person.

#### How do you fill out these documents?

You can apply for an order of protection or an injunction against harassment at the website - AZPOINT.AZCOURTS.GOV. Once the petition is completed, the confirmation number can be given to your local court, and they will schedule a hearing with a judge for that same day.

Once an OOP is granted and served to the defendant, it is good for 2 years. The defendant has one opportunity to contest the OOP. If the defendant requests a contested hearing, a hearing will be scheduled, and the judge will decide if the order should remain in place.

\*Before getting an order of protection or an injunction against harassment, it is important to remember that it is only a piece of paper. These protective orders could escalate the level of violence. If there are any concerns or questions, contact Victim Witness Services to talk to an advocate. We can help do safety planning and answer any questions about filing a protective order. \*

As VWS goes into our 40th year as a nonprofit, we thank you for your ongoing support and look forward to serving Northern Arizona for another 40 years.



#### Jordan's Story

Jordan<sup>\*</sup> was referred to VWS by local law enforcement after they responded to a domestic violence call at her residence. Her partner became angry with Jordan for coming home later than she promised, and he broke her phone and their shared computer. When speaking with Jordan, she mentioned this was not the first time her partner became violent; he has been physically and verbally abusing her for months. Jordan expressed her desire to move to California to live with her family and start fresh. VWS helped Jordan file an order of protection against her

partner and worked with a local domestic violence shelter to get her a bed for a few days before she leaves for California. Additionally, we coordinated with local

law enforcement to assist in a civil standby so Jordan could pack up some belongings. An advocate bought Jordan a Greyhound bus ticket to California where her family would pick her up. We transported her to the shelter and several days later to the bus station and sent her off with a hot meal to eat on the bus.

Jordan's advocate checked in on her periodically during the next month. Jordan expressed that she is happy to be with her loved ones and away from her abuser. She explained she has a job interview in the coming days and is hopeful for the future.
